total annual project volume funded by EU and IFIs: > 50 bn EUR


IFIs are The World Bank Group, The European Bank for Reconstruction and Development (EBRD), regional development banks like the Asian Development Bank (ADB), the African Development Bank (AfDB), the Black Sea Trade and Development Bank (BSTDB), etc.

additional financing by bilateral development banks like the Austrian Development Bank (OeEB), the German DEG-KfW etc.

every year about 100 Austrian companies participate in EU and IFI financed projects total contracting volume > 200 mio EUR




AUSTRIAN COMPANIE'S SHARE IN WORLD BANK FINANCED CONTRACTS - in US\$ between 2000 - 2007






WHO WINS MOST OF THE CONTRACTS? in US\$ 1.000 between 2000 - 2007






WHO WINS MOST OF THE CONTRACTS AMONGST OECD MEMBERS? - in US\$ 1.000 between 2000 - 2007






DEVELOPMENT OF AUSTRIAN CONTRACTING VOLUME in US\$ 1.000 between 2000 - 2007





AUSTRIAN CONTRACTING VOLUME BY SECTORS


in US\$ between 2000 - 2007

in US\$ 1.000 between 2000 - 2007






NETWORK PROJECTS INTERNATIONAL: OUR SERVICES





ATCs - THE AUSTRIAN TRADE COMMISSIONS

- inform about project opportunities
- identify local partners
- establish contacts with implementing agencies
- establish contacts with the World Bank's country offices
- obtain bidding documents
- deliver company's bid
- participate in bid openings as representative of company
- intervene for company in case of conflict with implementing agencies
- etc. etc.



ATC NEW YORK-BRANCH OFFICE IN WASHINGTON DC

- responsible for World Bank + Inter-American Development Bank (IDB)
- distributes information about business opportunities
- maintains large network in the World Bank and the IDB
- identifies the right contact persons
- establishes contacts and arranges individual appointments
- organizes Trade Missions and Sector Missions
- trouble shooting makes official representations with the Banks
- assists with questions reg. procurement procedures
- lobbies for Austrian strategic business interests
- etc. etc.
